Boating—Age Restrictions

PWC (Personal Watercraft, known by the common trade of Ski-Doo, Waverunner, SeaDoo, etc.):

- Children under 12 may not operate PWC, not even with an education certificate.
- Children 12 to 15 can operate PWC as long as they are UNDER DIRECT SUPERVISION of a an adult (18 or older) who is ONBOARD and as long as the child AND the supervising adult (if born on or after January 1, 1982) have education certificates.

For Powerboats (besides PWC) greater than 10 HP:

- Children under 12 can operate any other type of powerboat greater than 10HP as long as they are under the direct supervision of an adult (if born on or after January 1, 1982) have education certificates.
- Children 12 and over may operate type of powerboat greater than 10HP as long as they have an education certificate. Adult supervision is not required.

Avoid Exceeding Capacity

Jet ski must be rated for 3 persons min to pull a tuber.
Those being towed are included in your capacity.

A 2 person jet ski MAY NOT pull a tuber.

A 3 person jet ski may pull 1 person on a tube

A 4 person jet ski may pull 2 persons on a tube

You must count your driver, spotter, and those being towed for capacity.

Those on the 2 pay plan ARE eligible. One vote allowed per membership regardless the number of lots you own. Associate members do not qualify for voting, must be a deed holder.

Ballots being mailed must be post marked by July 31st. You can also drop off ballots directly to the lodge office by July 31st.



FISH COMMITTEE

Daily limits are 8 perch per day at least 10" and 2 walleye at 16", members only.



2020 HLPOA Wristbands are available to members who have paid in full for membership fees. Bands can be picked up at the lodge office.

COMMONLY VIOLATED BOATING RULES

- **No jet ski operation between sunset and sunrise.
 - **Exceeding capacity on jet ski's. Those being towed are counted in your capacity limit for the watercraft.
 - **No sitting on bow or gunnels while in motion. No persons should be sitting on the front of a pontoon while in motion.
 - **Keep to the right of the shoreline. Be sure to pass on the left.
 - **2020 Blue HL boat stickers must be on all motorized watercraft.
 - **Navigation Lights must be used at night—use lights that can be seen from all sides. Parking lights (headlights) are for parking.

Drive around the lake via boat , golf cart, or car & enjoy the decorated homes. Feel free to leave lights up for all to enjoy through the week

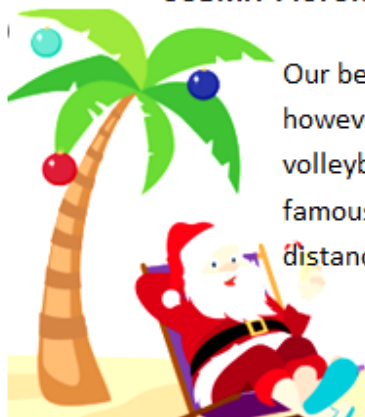
Scavenger Hunt– Pick up clues 24-25th outside the office from tote, or print from Nextdoor, or Facebook.

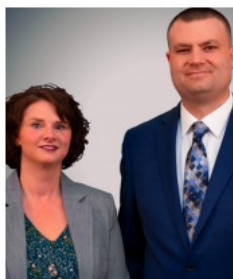

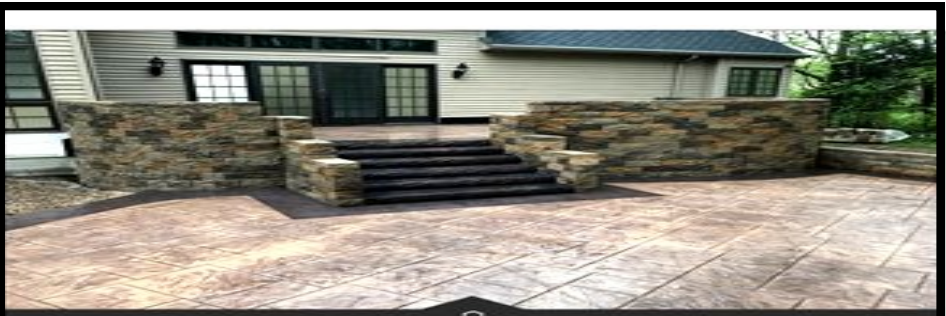

***Effective December 2012 no permit required for the following:** Roof, Siding, Window/Door replacement

Members will be assessed a \$250.00 fine* if found *doing construction on any of the above projects without applying for and obtaining a construction permit and/or posting a performance bond prior to any work being done.* Failure to do so will result in a \$200.00 per month fine assessed to the property owner until all construction has been terminated and removed and restored. All work must comply with dimensions and setbacks of Holiday Lakes Building and R.C.O. Codes*.

If more than one line item is to be performed at the same time, each permit fee applies. The only exception is a New Home Permit, which includes septic, culvert, and drive. No combining multiple jobs into one permit. If work is started without applying for and receiving permit with approved plans, the permit fee will be doubled, plus \$250.00 fine.

PLEASE SUBMIT A SITE PLAN WITH EACH PERMIT REQUEST

New Homes, Additions, Detached Garages : Township zoning permit needed in addition.

SUBMIT ROAD BOND for \$250 for any heavy equipment that will cross H.L. roads for construction of any kind not mentioned above.

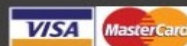

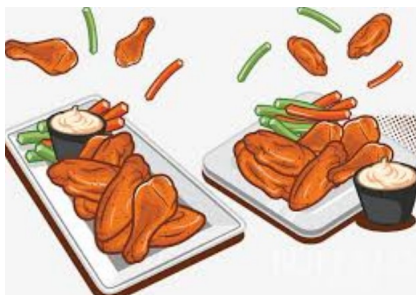
